It is the policy of St. Paul's School that no student will transport himself, or anyone else, to School activities such as, but not limited to, a field trip, service learning trip, off-campus game or meet, performance, or practice ("Activity" or "Activities") without completion of this transportation waiver, indemnity and release form. If a student transports himself and/or others to an Activity in violation of the above policy, the driver and any passengers will be ineligible to participate.

I am the student or the parent or guardian of the student identified above. I understand that on certain occasions School Activities may be conducted at a location away from St. Paul's School campus. I understand that in certain circumstances St. Paul's may provide transportation to and/or from such Activities. In requesting that my student be permitted to participate in these Activities, I agree that my student will ride in School-provided transportation when the School requires my student to do so.

I further understand that in certain circumstances St. Paul's may not provide, or I may choose not to utilize, the School's transportation for such Activities. In requesting that my student be permitted to participate in these Activities, I agree that in those circumstances where the School does not provide, or I choose not to utilize, transportation to such Activities, I assume full responsibility for personally transporting, or arranging transportation of, my student to and from such Activities.

I acknowledge that if I elect to utilize transportation other than the School's transportation to and from an Activity, or if School transportation is not provided, any decision I make to allow my student to drive himself, or to ride in a vehicle driven by any other person, including but not limited to another student or the parent or guardian of another student, is solely an exercise of my discretion as a parent or guardian. I acknowledge that the assessment and decision whether it is safe to allow my student to drive to or from a particular Activity, or to ride with any other person, including but not limited to another student, parent or guardian who is driving, is a family assessment and decision to be made by me or between me and my student. **If my student chooses to drive himself or to drive with any other person, including but not limited to another student, parent, or guardian, to or from an Activity without my permission, I assume full responsibility.**

In consideration of the opportunity for my child to participate in School Activities, I agree that my student, or any other person who may be driving my student to or from an Activity, shall not be considered an agent or servant of the School, in any respect or for any purpose, while driving to or from such Activity. I further agree that should any claim be made against the School based on the conduct of any such person providing transportation to an Activity, including my student, while they are providing such transportation, I will defend, indemnify, and hold harmless St. Paul's School, its Headmaster, coaches, and any employees or volunteers from any liability arising out of or related to such a claim.

I further hereby intentionally and knowingly waive any claims, demands, actions and causes of action against St. Paul's School, its Headmaster, coaches, and any employees or volunteers arising out of or relating to any loss, damage, or injury sustained in connection with my student's participation in this Activity.
